To complete the Global Business Practices to Improve the Human Condition minor, students must pass the 18 credits of required and elective classes listed below with an average of a 2.5 in these courses. Students must complete at least 6 out of the 18 credits at the 3000-4000 level. No course grade may be lower than a C- to earn the minor. Additionally, students must complete an approved experience with a social or economic change component approved by Pamplin International Programs. The minor will be noted on the student's transcript.
